  2. Blank tender forms will be available at Jalgaon Janata Sahakari Bank Ltd., CTS NO - 491/A/4, TPS No.3, Parijat Sankul, Jalgaon – 425002, from 06/07/2026 to 10/07/2026 (11 am to 5 pm) on working days (Non refundable cost Rs 500/-)
  3. A Pre-Bid Meeting, if required, of prospective Tenderer who choose to remain present will be held on site so that the Tenderer will have an opportunity to obtain clarifications regarding the work and tender conditions. Date and time of Pre-bid meeting on site with Architect and Bank Officer will be informed separately.
  4. The tenders should be submitted in a sealed envelope addressed to the Chief Executive Officer, Jalgaon Janata Sahakari Bank Ltd. at branch on or before 10/07/2026, 5 PM.
  5. Please note that this will be an Item Rate Tender.
  6. The tenders must be accompanied by a Demand Draft of Rs.15,000/- being Earnest Money Deposit drawn in favor of Jalgaon Janata Sahakari Bank Ltd. Jalgaon. The Earnest Money Deposit shall be returned to the unsuccessful tenderer. The Earnest Money Deposit shall be converted into Security Deposit in case of the successful tenderer and the said amount will remain with the organization till satisfactory completion of the contract. No interest shall be paid on the said Deposit.
