3. The contractors who want to submit the tenders should submit the same in a sealed envelope to the Chief Executive Officer (O) on or before 22/12/2023, 6 PM .
4. The tenders must be accompanied by a Cheque / Demand Draft or Rs 15,000/- being Earnest Money Deposit drawn in favour of Jalgaon Janata Sahakari Bank Ltd. Jalgaon. The Earnest Money Deposit shall be returned to the unsuccessful tenderer.
